### From 71 South

Take Broad Street Exit at Downtown Columbus.
Turn Right onto Broad Street.
Travel to Fifth Street (which is 4th traffic light).
(St. Joseph's Cathedral on Right)
Travel thru light to first alley on left (Young Street)
Turn Left on Young Street
Travel approx 75 yds to Capitol Street and turn Right
Turn Right again immediately into the parking lot.

### From 71 North

Take Broad Street Exit at Downtown Columbus.
Turn Left onto Broad Street.
Travel to Fifth Street (which is 5th traffic light).
(St. Joseph's Cathedral on Right)
Travel thru light to first alley on left (Young Street)
Turn Left on Young Street
Travel approx 75 yds to Capitol Street and turn Right
Turn Right again immediately into the parking lot.

Club is located at the corner of Fourth St. & Young St. Black wrought iron fence encompasses entire block of club's location. Appears as a large brick mansion with parking lots on both sides of club.
